PAPER FORMAT

Papers will be written in English and will be of maximum 10 pages long.

Papers must comply with the guidelines described in the IECS 2015 Template. The organizing committee reserves the right to reject submissions that do not comply with this format.

Participants can send either *an individual paper or two papers in collaboration*. The organizing committee will *not accept papers with more than 3 co-authors*.

All submissions are subject to a *double blind review process*. Papers will be evaluated for originality, significance, clarity, and contribution.

Accepted papers will be published after the conference in the Conference Proceedings (CD with ISSN), *Procedia Economics and Finance* (<http://www.journals.elsevier.com/procedia-economics-and-finance>), *Revista Economică* (<http://economice.ulbsibiu.ro/revista.economica>), *Studies in Business and Economics* (<http://eccsf.ulbsibiu.ro>) or *Bulletin of Taras Shevchenko National University of Kyiv. Economics* (<http://bulletin-econom.univ.kiev.ua>)

Until the conference may emerge other publication opportunities for participants.

REGISTRATION FEE

In case the paper is multi-authored and more than one author would like to participate in the conference, each participant pays the registration fee separately. The conference package will be available only for the authors who attend.
